ADAC breakdown and accident assistance for ADAC members

Revised on 1 January 2014

1. When does your ADAC membership begin and end?

- Your ADAC membership starts in the month your application is received, if no later commencement has been expressly agreed.
- The membership can only be terminated in writing by giving three months' notice before the end of the subscription period.

2. When does your cover begin and end and when do you have to pay the membership fee?

- Insurance cover starts at 0:00 hrs on the day after the application for ADAC membership is received and accepted and if no later membership start date has been agreed. If any later start date has been agreed, your entitlement to benefits starts at 0:00 hrs on the first day of the month agreed. Moreover, the first membership fee must be paid in time. It is deemed to be paid in time,
 - if you pay when you subscribe
 - if, should you pay by bank transfer, we receive the amount due within the deadline indicated on the invoice
 - once the bank has executed your direct debit order.If payment is late, you are not entitled to any benefits before we receive your membership fee, unless you cannot be held responsible for the delay.
- Renewal fees must be paid in advance and are due on the first day of the month in which a new membership year starts. You are not eligible to receive benefits for claims arising after the deadline mentioned in the reminder, if the membership fee has not been paid. Later payment of the membership fee will not reinstate cover.
- Our duty to perform ends upon the expiration of the membership.

3. What are the services ADAC members receive after a breakdown or accident in Germany?

A breakdown is defined as a brake or operation failure or breakage. An accident is a sudden external event damaging the vehicle with mechanical force.

a) Breakdown or accident assistance (from your doorstep):

A vehicle covered by ADAC membership has lost technical roadworthiness following a breakdown or accident in Germany. Our ADAC road patrol or - up to €300.00 (including call-out and all transported small parts) - an ADAC contractor will provide roadside assistance at the site of the incident in order to restore the vehicle's mobility.

b) Towing (from your doorstep):

A vehicle covered by ADAC membership has lost technical roadworthiness following a breakdown or accident in Germany. An ADAC contractor will tow the vehicle directly from the site of the incident to the nearest suitable garage or to a requested place situated at equal distance. Costs will be covered up to €300.00. ADAC will pay any storage and deposit fees, if applicable.

In addition, an ADAC contractor will transport luggage and cargo up to €300.00 if they cannot be transported with the vehicle. The transport of animals and commercial goods is not covered.

c) Off-road recovery:

Due to a breakdown or accident in Germany, a vehicle covered by ADAC membership has come off the road and can only be made ready for towing or onward journey with considerable technical effort.

An ADAC contractor will recover the vehicle including luggage and cargo, animals and commercial goods excepted. All costs will be covered.

4. Which vehicles are covered?

- The cover includes motor vehicles not requiring registration and registered vehicles which you, as an ADAC member holding a valid driver's licence operate as the solely responsible driver or are about to start at the time of the incident. In addition, the vehicle must have become immobilised in Germany following a breakdown or accident on a public road or in a public or private parking lot or garage which is directly accessible from a public road and the site of the incident must be accessible with assistance vehicles.
- The cover also includes an attached trailer with no more than one axle. Two axles spaced less than 1.00m from one another are considered one axle. Your car and caravan/trailer are covered only once and together as a rig.
- Based on the design and the facilities for the transport of persons, the vehicle may not have more than 9 seats (including the driver's seat) and must not exceed
 - a total width of 2.55m,
 - a total length of 10m,
 - a height of 3m,
 - a maximum gross weight of 3,500kg.All dimensions indicated also apply to the attached trailer. And they refer to the vehicle including load.
- The cover also includes motorhomes listed on the registration certificate up to
 - a height of 3.2m including load and
 - a maximum gross weight of 7,500kg.
- Cover is not provided for vehicles that are totalled, vehicles or their cargo confiscated or seized by the police, vehicles used for the commercial transport of persons, except taxis, vehicles during road testing and delivery drives (red dealers' plates for recurring use).

5. How to make your ADAC membership claim.

- As an ADAC member you are personally entitled to ADAC assistance services. This right cannot be assigned to third parties. There is no right to reimbursement of costs incurred.
- ADAC members must expressly request assistance by ADAC, also when calling from an emergency call box on the motorway or a police station, and always provide ADAC membership identification.
- Your statements regarding the claim must be true and complete and supported by adequate documentation.
- The club service is not free of charge, if the same services were provided more than once because of the same failure or defect, or if the damage was caused by gross negligence or deliberately or if you are eligible to claim compensation from a third party. Third parties do not include ADAC-Schutzbrief Versicherungs-AG, ADAC-Rechtsschutz Versicherungs-AG and ADAC Autoversicherung AG.

6. Liability in the event of defaults in performance

In the event of any default in performance when providing breakdown and accident assistance, ADAC will assume liability, if ADAC or its contractors acted deliberately or with gross negligence, unless material breach of contract or physical injury are involved. If a vehicle is transported, ADAC will assume liability according to the legal provisions of the German Commercial Code (HGB) applying to carriers as amended at the time of the incident, however in excess of the legal limit up to €512,000.00.

Withdrawal information

You are entitled to withdraw your membership within 14 days without having to give any reason. The period of withdrawal is 14 days and starts on the effective date of the contract, however not before you receive your membership documents.

To exercise your right of withdrawal, you must explicitly declare - e.g. send a letter by mail to ADAC e.V., Hansastrasse 19, 80686 München, by fax to +49 89 76 76 48 66, by e-mail to service.vertragsaenderung@adac.de or phone at +49 89 76 76 66 32 - your decision to withdraw your membership.

For this purpose you may use the withdrawal form which we provide with the membership documents. To use this form is not mandatory. Your withdrawal will be in time if dispatched before the expiry of the withdrawal period.

Consequences of withdrawal

If you withdraw your membership, we shall refund all payments received from you without delay but no later than 14 days from the date on which we received your declaration to withdraw your membership. For this reimbursement we shall use the same means of payment that you used when making the transaction unless you expressly agreed otherwise; in no event shall the reimbursement incur any fees. If you required the membership to commence during the period of withdrawal, you will be obliged to pay the membership fee relative to the time before your withdrawal.

Information about the processing and use of data

1) Use of your standard personal data

Within the scope required, ADAC (ADAC e.V., its subsidiaries and regional clubs, in the insurance, car rental, publishing, financial services, and tourism business) will store general membership and contract data gathered from the application documents or in the course of contract performance (e.g. membership fees, risk/contract modifications) in joint databases and transmit this data to ADAC cooperation partners only where absolutely required for the provision of contractually agreed services. When verifying and processing an insurance application or claim, we may be required to liaise with other insurers in accordance with §28 (1) s. 1 no. 2 and §28 (2) no. 2a of the Federal Data Protection Act (BDSG). This will also include ADAC answering requests from other insurers and transmitting data to reinsurers in line with said provisions.

2) Health data/waiver of confidentiality

Health data may exclusively be transmitted to the applicable service providers (e.g. assistance centres, the air rescue and ambulance services). In the event of a claim, it may be necessary for the verification of the insurer's liability that the insured releases physicians and other authorities relevant for the verification and handling of the case from their duty of confidentiality as provided in §213 of the German Insurance Contract Act (VG).

3) Use of your standard personal data for advertising

Within the framework of §28 (1) s. 1 no. 2 and §28 (3) of the Federal Data Protection Act, ADAC (ADAC e.V., its subsidiaries, its regional clubs and ADAC Autoversicherung AG in the insurance, car rental, publishing, financial services, and tourism business) also collects, processes and uses your application, contract and service data for market research and advertising purposes.

You are entitled to revoke the use of your data for advertising and market research purposes at any time by mail, fax or email.
